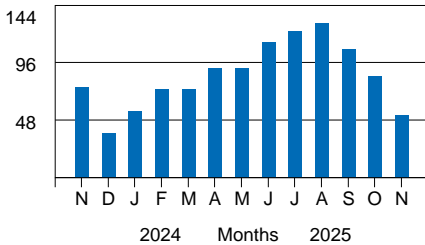

kWh - Average Per Day

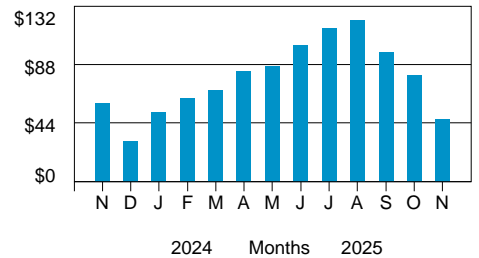
