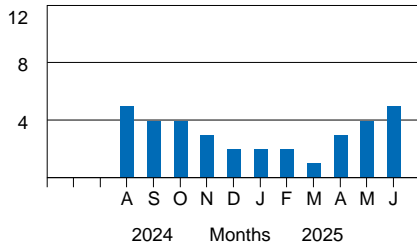

**kWh - Average Per Day**

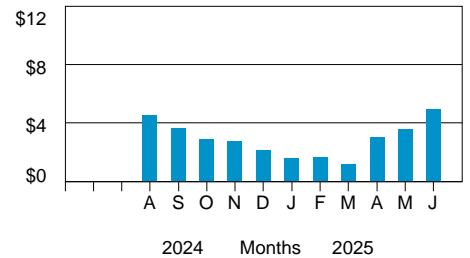
