<p>Subscription Fee and Savings Rate</p>	<p>Each month, you will receive credits on your electric utility bill based on the electricity generated by the project. Your subscription fee will be automatically taken from the credits you receive on your utility bill. Your subscription fee is equal to 90% of the value of the credits you receive each month. After the credits are reduced by the subscription fee, you will receive savings equal 10% of the credits you receive. You will not be charged any other fees.</p>
