The price for SOS from June 1, 2025 through September 30, 2025 will be set in November 2024.

Hot days, cool choices: Energy-saving tips for warm weather

TAKE ADVANTAGE OF ENERGY SAVINGS DAYS.

You can earn \$1.25 in BGE bill credits for every kilowatt-hour of electricity that you reduce your electricity usage on an Energy Savings Day (2 p.m.—6 p.m.), compared to what you would normally use.



Clean or replace air filters

Savings estimate: \$85 a year.

Heating and cooling consume the most energy in the average home—up to 50% of total home energy use. By cleaning or replacing your filters, you can lower your heating and cooling system energy use by up to 15%.



Install window shades such as blinds or shutters

Savings estimate: \$50 a year.

If the sun creates overwhelming heat in your home during the warmer months, you can improve your comfort and lower your cooling costs by adding shading to your windows.



Use a programmatic thermostat

Savings estimate: \$180 a year.

By adjusting your thermostat 7-10°F for eight hours a day, you can save on heating and cooling costs.

Smell: BGE puts mercaptan, a safety additive in natural gas to give it a rotten egg odor and make it easier to detect.

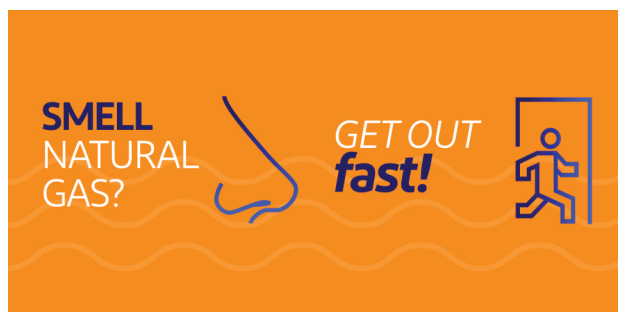


See: Look for dead vegetation in a thriving area, bubbling ground water, or blowing dust from a hole in the ground.



Hear: A blowing or hissing sound.

Shift. Reduce. Save

You can enroll in **BGE's Time of Use rates** (Schedule RD), giving you an opportunity to save on your electricity bill. Here's how it works:

Rather than paying a flat rate for your electricity use, you pay a lower rate during off-peak hours and a higher rate during peak hours, except on designated National Holidays.

- Peak hours from October to May are **weekdays 6-9am and 5-9pm**.
- Peak hours from June to September are **weekdays 3-8pm**.

When you reduce your electricity usage during peak hours or shift it to off-peak hours, you can see savings on your electricity bill.

The more you shift your usage, the more you can save. You can switch back to the standard flat rate anytime.
