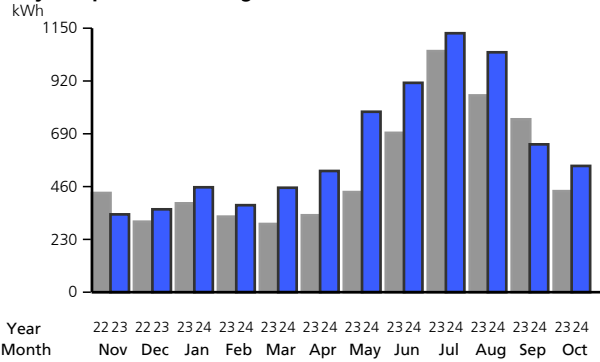

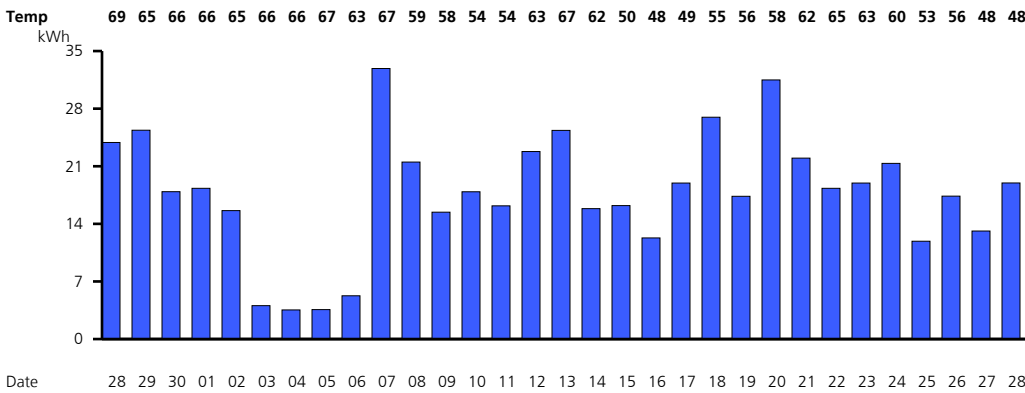
Your monthly Electricity use in kWh

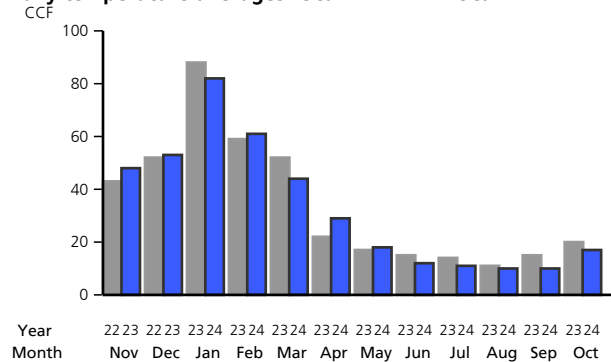
