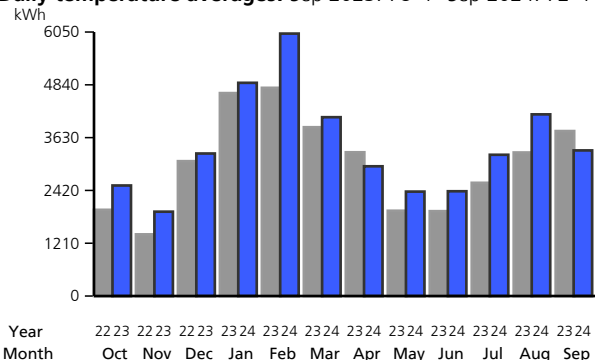

Effective September 1, 2024, the average residential customer, using 811 kWh, will see a monthly bill decrease of \$0.59 as a result of a change in the Transmission Service Charge. For commercial and industrial customers, effects of this change will vary with usage. Transmission charges pay for the costs associated with moving electricity from power plants over high-voltage lines and towers to the distribution system.

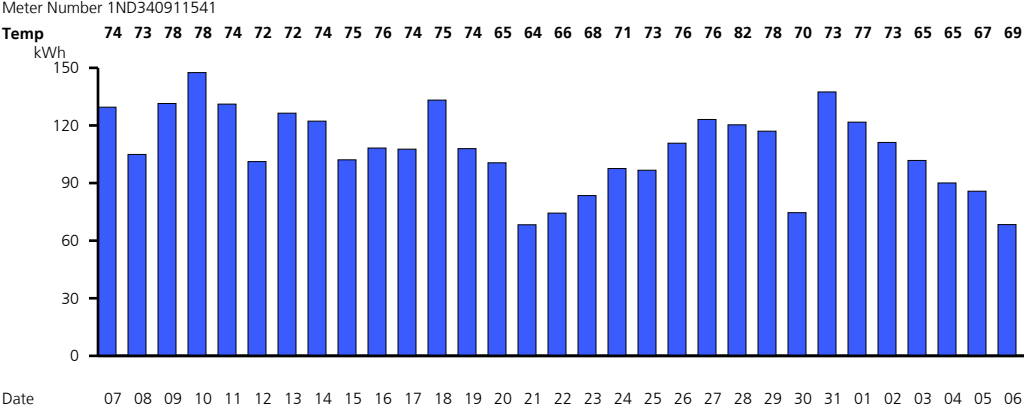
Both the "Wind & Solar" and "Qualified Fuel Cell" portions of the Renewable Compliance Charge above provide compliance required by Delaware's Renewable Energy Portfolio Standards Act. The Qualified Fuel Cells provide customers with approximately 30% of that compliance annually. For more on renewable and clean energy, visit delmarva.com/repsa.

The Delaware Public Service Commission approved a settlement in Delmarva Power's electric delivery rate review. As a result, your current bill includes a one-time refund, with interest, reflecting the difference between interim rates billed from July 15, 2023 to April 23, 2024, and the approved final rates.

You can help a Delmarva customer in need of assistance with their energy bills by contributing to the Good Neighbor Energy Fund. Simply pay exactly \$1.00 over your Delmarva bill amount and that dollar will be contributed to the Good Neighbor Energy Fund administered by a 501(c)3 non-profit organization in your community. Contributions must be exactly \$1.00 over the billed amount; amounts over \$1.00 will result in a credit to your account. Delmarva Power will also contribute \$1.00 to the fund for every \$3.00 in customer donations, up to \$70,000.
