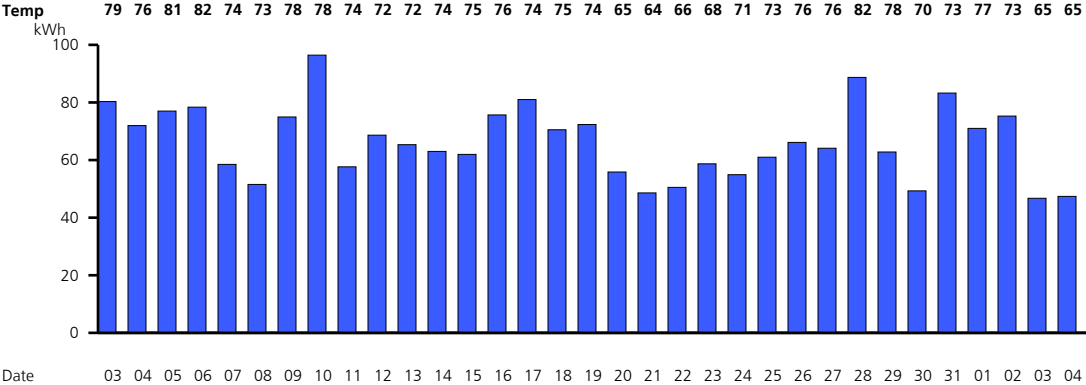

The Delaware Public Service Commission approved a settlement in Delmarva Power's electric delivery rate review. As a result, your current bill includes a one-time refund, with interest, reflecting the difference between interim rates billed from July 15, 2023 to April 23, 2024, and the approved final rates.

You can help a Delmarva customer in need of assistance with their energy bills by contributing to the Good Neighbor Energy Fund.
