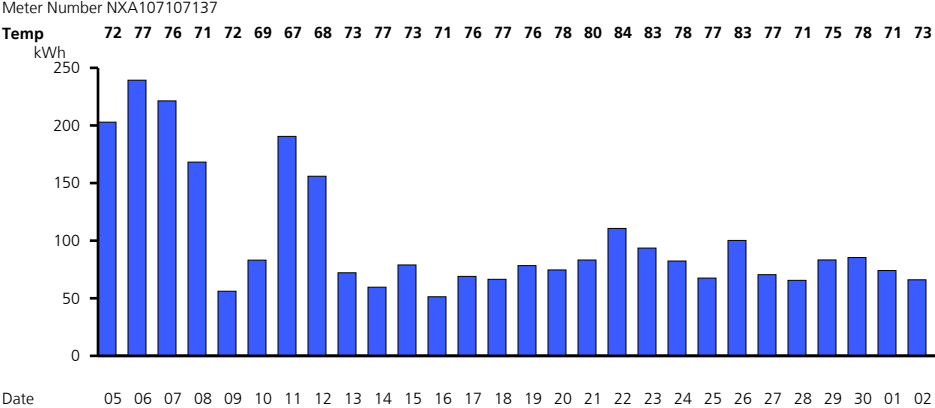
Both the "Wind & Solar" and "Qualified Fuel Cell" portions of the Renewable Compliance Charge above provide compliance required by Delaware's Renewable Energy Portfolio Standards Act. The Qualified Fuel Cells provide customers with approximately 30% of that compliance annually. For more on renewable and clean energy, visit delmarva.com/repsa.

Effective July 1, 2024, the Distribution System Improvement Charge (DSIC) was adjusted to 2.84% of delivery charges for electric customers. It is subject to a review and approval process by the Delaware Public Service Commission and adjusted periodically.

You can help a Delmarva customer in need of assistance with their energy bills by contributing to the Good Neighbor Energy Fund.
