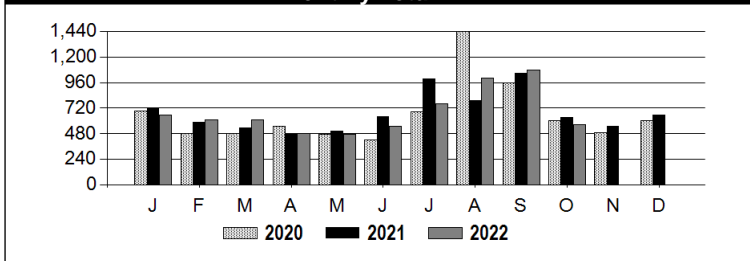

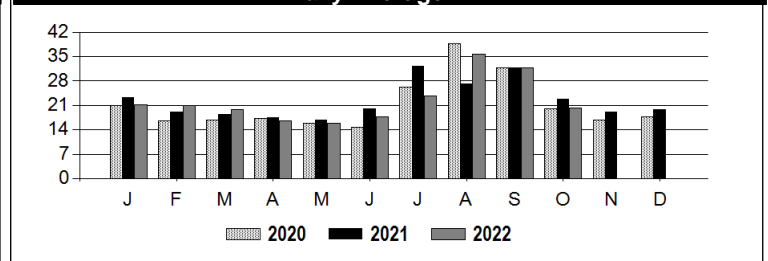

for the first 750 kilowatt hours (kWh) of residential usage.

Estimated Bill- If we are unable to obtain a scheduled meter
reading, your bill will be estimated based on the amount of kWh
consumed based on past usage.

Late Payment- The amount not paid by the Due Date on the bill
will be subject to a late payment fee of 0.267% on the
unpaid balance.

Payment arrangement- If you have trouble paying your bill, a
payment arrangement may help. Please call customer service for
more information.

kWh (kilowatt hour)- The amount of electricity you use is
measured in kilowatt hours (kWh) by a meter. For example, a
100-watt light bulb used for 10 hours will consume 1,000 Watt hours,
or one kWh.
